Office Order

Pursuant to the recommendations of the committee met on 10th May, 2014 and approval of the Hon'ble Vice-Chancellor, SKNAU, Jobner the rates of testing fee for variety/hybrid/agrochemicals/products etc. is @Rs. 1.5 lac (Rs. one lac fifty thousands) per product /variety/hybrid/agrochemical, per location, per season payable to the Comptroller, SKNAU, Jobner and norms for the utilization of testing fee will be as under:

- 1) 40% as recurring contingency for the P.I.
- 2) 5% honorarium to P.I. and associated scientists
- 3) 10% for station development
- 4) 35% as institutional charges in the Comptroller's Office (20% in the Comptroller's account as the University income and 15% as the University development fund)
- 5) 10% as institutional charges in DOR office.

The trial would have to be conducted for at least two seasons. For any follow-up studies in the succeeding season of the trial, Rs. 75000/- (Rupees seventy five thousand only) will be charged as additional testing fee. This order will be effective from 01.4.2014
